- (1) In the new HR manual, the faculty member publication allowances were not mentioned (Earlier allowance was fixed as Rs.2000/- for each SCI indexed paper publication).
- (2) University Rank incentives per month (Rs.2000/- for UG Rank holders and Rs.1000/- for PG Rank holders) are not mentioned in the HR manual.
- (3) Incentives to faculty members for consultancy and patents are also not available.

He also suggested not to discontinue the incentives.

- Dr. V. Ramachandran informed that, special incentives are covered under faculty performance appraisal, and faculty may get Rs.3000/- to Rs.5000/-, based on their performance. In addition, the entire faculty would get 3% Annual increment.
- Dr. P. Kaliraj suggested that documents like HR manual should be discussed first with the entire faculty members and their suggestions must be collected. Then it must be discussed with HoDs and the Principal. Their suggestions should be recorded. Afterwards, it should be submitted in GB. After GB's approval, it should go to Managing Board's Approval.

Dr. T. Rameshbabu has also agreed with the view of Dr. P. Kaliraj.

Mr. A. Kubera Raja also stated that, HR manual should be consulted with the staff members before submitting for

		Dr. M. Vasanthi brought to the notice of the members about the loop leave clause. In HR manual clause 6.2.8, it is mentioned that "Casual leave can only be suffixed or prefixed with holidays / weekly off days". For example, suppose Friday is Government holiday, if any faculty member availed casual leave on Saturday, then three days casual leave has been deducted from their total leave. It was proposed that this clause could be removed.
